## The Pronouncement of the Final Decision Regarding the Investigation on Undertakings Operating in the Field of Elevator Maintenance and Repair in the Niğde Province according to Article 49 of the Act no 4054 on the Protection of Competition

The settlement texts submitted based on the settlement interim decisions numbered 24-54/1194-MUA, 24-54/1195-MUA, 24-54/1196-MUA, 24-54/1197-MUA, 24-54/1198-MUA, 24-54/1199-MUA, 24-54/1200-MUA, 24-54/1201-MUA, 24-54/1202-MUA, 24-54/1203-MUA, 24-54/1204-MUA, 24-54/1205-MUA, 24-54/1206-MUA and 24-54/1207-MUA, taken within the framework of the investigation launched with the Competition Board decision dated 15.08.2024 and numbered 24-33/786-M, were entered into the Authority records within the due period by STRONG ASANSÖR, UPAS ASANSÖR, AVCI ASANSÖR, EÇ ASANSÖR, DMR ASANSÖR, BOR KONFOR ASANSÖR, 51 ASANSÖR UGR ASANSÖR, TYANA ASANSÖR, NİĞDE ASANSÖR, ÇAĞRI ASANSÖR, BOR ASANSÖR, ANIL ASANSÖR and SİSTEK ASANSÖR with the numbers 60630, 60632, 60631, 60636, 60635, 60634, 60633, 60816, 60815, 60813, 60812, 60810 and 60809 on 25.12.2024 and on 31.01.2025 with the number 60812, respectively. In the settlement texts, the undertakings explicitly accepted the existence and scope of the violation, as well as the maximum rate and amount of administrative fines specified in the settlement interim decisions; consequently, it was decided that

II- Accordingly, the following administrative fines over their gross revenues in 2023 should be imposed on the undertakings indicated below, under Article 16.3 of the Act no 4054 and Articles 5.1(a), 5.2, 5.3(a) and 7.1 of the Regulation on Fines to Apply In Cases of Agreements, Concerted Practices and Decisions Limiting Competition, and Abuse of Dominant Position,
